I am pleased to inform you that ABIME is doing well and growing. ABIME certification represents the pinnacle of professional competency and integrity. The prestigious distinction of certification through the American Board of Independent Medical Examiners sets you apart as an internationally recognized medical examiner. There are over 2000 physicians listed in this Directory.

As you know ABIME Certificate expires 5 years after its original issue date unless recertified by re-examination or via Alternate Pathway without re-examination. If your ABIME Certificate (CIME/CICE) is expired please note the following ABIME Policy:

ABIME Certified Doctors (Diplomats) must accurately state their certification status at all times. This includes descriptions in curriculum vitae, advertisements, publications, directories and letterheads. Diplomats with expired time-limited certification may not claim board certification and must revise all descriptions of their qualifications accordingly. When a physician misrepresents certification status, the Board may notify credentialing bodies, licensing boards, law enforcement agencies, and others.

ABIME Certified physicians pay \$185.00 annually to qualify for a variety of Benefits, Programs, and Services including publication of their names in the print directory. A new print directory will be published yearly. As you know IME schedulers, case managers, insurance companies, attorneys, Workersø Compensation Boards and others utilize the ABIME Board of Registry directory when searching for certified physicians to perform IMEs. By providing them with the print directories and necessary information about you helps to direct more referrals to your practice. **ABIME can not provide leadership for your cause without your support. Your continued support of ABIME BOR is needed and appreciated.**
